

AGRIBITION OPEN CATTLE DOG CHAMPIONSHIPS

FOOT TRIAL: 8:00 AM, WEDNESDAY, November 27 – Brandt Centre

MOUNTED TRIAL: 12:30 PM, WEDNESDAY, November 27- Brandt Centre

Start times for Trial will be confirmed, and handlers will be informed following closing of entries. Finals will be held following the trials.

PRIZE MONEY: \$9,000 Prize Pool

RULES

1. All entries are subject to the General Rules and Regulations of CWA. Please refer to these rules and read them carefully.
2. **Entry Fees Foot Trial:** \$205/dog plus GST. **Limit of 25 dogs.**
Entry Fees Mounted Trial: \$230/dog plus GST. **Limit of 20 dogs.**
Entries open September 1, and close October 1. Handlers are only able to enter one of the cattle dog events, either the foot trial, or the mounted. If entries permit, this may be opened and if so, you will be notified. Entries will be accepted online at <https://app.agribition.com/livestock/sign-in>.
3. If trials do not fill, second dogs may be entered for an additional fee of \$20.00/dog. If you wish to enter a second dog, please email Kiah Simpson @ ksimpson@agribition.com with your name, contact information, and the dog's name. Random selection of entries will occur.
4. Entry fees will not be refunded, except in cases where entries are cancelled on or before the tenth day following the closing of entries (October 10th). If the contributor's entry is made ineligible for show at Agribition due to the health status of entry, and a written request, accompanied by a Veterinary Certificate, is submitted to the CWA Stock Dog Committee, the two-thirds of the entry fee may be refunded, subject to the discretion of the CWA Stock Dog Committee.
5. Stalling will be available for horses in the outdoor tent for the day. Please follow arrival instructions that will be circulated upon completion of entries. Trailers can not be left parked on site and must be taken to the trailer parking at Rambler Park. Overnight stalling can be available upon request. Please contact Kiah Simpson @306-924-9592 or ksimpson@agribition.com to request overnight stalling. Shavings will be available for purchase on site if needed.
6. Any dog that enters the trial field during another dog's trial will be handled at the discretion of the CWA Stock Dog Committee members and Judge.
7. Reckless handling of stock is grounds for dismissal at the discretion of the judge.
8. Timing will start when the cattle are in the arena and arena gate is closed or when dog is sent. The handler will call for his cattle. The time limit will be announced at the handler's meeting.
9. **TOP DOG AWARD:** Additional prizes will be awarded if the same dog wins the International Stock Dog Trial and either the Mounted Cattle Dog Trial or the Foot Cattle Dog Trial. A minimum of \$5.00 from each dog event entry fee will be set aside to contribute to a growing jackpot. The jackpot will continue to grow annually until a successful competitor wins it."
10. **Foot Trial: First Trial:** Running order as printed. All dogs run. **Finals:** Top five will compete in the Finals from slowest to fastest time.
11. **Mounted Trial: First Trial:** Running order as printed. All dogs run. **Finals:** Top four will compete in the Finals from slowest to fastest time.
12. **Handler's Meeting:** Handler's will be notified following closing of entries.

The competition is sanctioned by the Canadian Cattle Dog Association and Saskatchewan Stock Dog Association.
